

Friends of Summers Field Newsletter Christmas 2013

It's been a busy year:

- In February we purchased a ride-on mower with grants from SGC and Big Lottery Awards for All.
- We then obtained planning permission to install a secure shed behind the village hall to house the mower. This was on the basis agreed with the Village Hall Committee that we could occupy the shed rent free in return for cutting the village hall grass.
- The shed was purchased and erected in April:



- Also in April we planted a further 10 fruit trees in the orchard completing the initial planting plan:



- Unfortunately one tree didn't survive the wet Spring, but all 27 of the others seem to be thriving.
- With the great weather we had during June and July we thought we were safe in planning a celebration barbeque, but as luck would have it Saturday 27th July turned out to be a wash out. The sight of Huw cooking under an umbrella will remain as a lasting memory though!
- In August Pete Dinham kindly scraped off the top soil for the trial area of the wild flower meadow with his digger:



- Our second Cider Festival fundraiser was held on 26 October and again proved very popular. The
 general consensus seems to be that the apple pie eating contest should not feature in future
 events, though! This year's event raised £537 compared to £487 last year, so many thanks are due
 to all that participated, donated puddings or prizes and helped with the preparation.
- A further 18 trees have been purchased with the remainder of the grant funding and 10 of these will be delivered and planted in a work party on Sunday 8 December. Volunteers will be welcome!

Future plans are to plant the last 8 trees next Spring, bringing the total to 44 and to continue the development of the wildflower meadow taking account of the results from the trial area. We are also planning to put up a notice board by the entrance gate.

Depending on availability of funds, the Parish Council is also planning to replace the stiles on the public footpath across the North side of the field with Marlow gates to improve accessibility (the stiles on the path behind the playing field would also be replaced as part of this project with all the gates being installed by the Cotswold Voluntary Wardens).

As always we will continue to need donations and membership fees to cover the annual outgoings which amount to £1300, so a response form is attached for anyone who would like to make a further donation or apply for/renew membership of the interest group (£10 per year).
